## Contributors to This Issue

**Timothy Brennan** received his PhD from Boston College in 2018. He is currently a postdoctoral fellow at the University of Texas at Austin, and is the author of articles in the *Review of Politics*, *History of European Ideas*, *History of Political Thought*, *The European Legacy*, and the *Journal of Politics*.

**Daniel Burns** is associate professor of politics at the University of Dallas, where he served as interim associate dean of the college of liberal arts in 2020–21. He has held fellowships at the University of Texas at Austin and at the Catholic University of America, and has also served full-time (during a period of academic leave) in the federal legislative and executive branches. His research on the relation between religion and citizenship includes among others Augustine, Locke, al-Farabi, Thomas More, and Joseph Ratzinger.

**Kimberley J. Burns** is affiliate assistant professor of politics at the University of Dallas, where she teaches classes in American politics and the history of political thought. She holds a PhD in political science from Boston College and a BA in philosophy from the University of Winnipeg. She contributed to the edited volume *The Rousseauian Mind* (Routledge, 2021) and is currently working on a book entitled *Rousseau's Religious Project*.

**Robert Faulkner** is professor emeritus of political science at Boston College, where he taught for forty-six years. His books include *The Case for Greatness: Honorable Ambition and Its Critics* (Yale University Press, 2007), *Francis Bacon and the Project of Progress* (Rowman & Littlefield, 1993), *Richard Hooker and the Politics of a Christian England* (University of California Press, 1981), and *The Jurisprudence of John Marshall* (Princeton University Press, 1968).

**Eve Grace** teaches political philosophy at Colorado College. With Christopher Kelly, she translated and edited volume 9 of *The Collected Writings of Rousseau* (University Press of New England, 2002), and edited *Rousseau on Women, Love, and Family* (University Press of New England, 2009), *The Challenge of Rousseau* (Cambridge University Press, 2012), and *The Rousseauian*

*Mind* (Routledge, 2019). She has written various articles and chapters on Rousseau for these and other publications. She is currently working with Chris on an English edition of selected correspondence by Rousseau.

**Claude Habib** is professor emerita at the Sorbonne Nouvelle in Paris. She is author of *Le consentement amoureux: Rousseau, les femmes et la cité* (Hachette, 1998), and editor or coeditor of three volumes of essays dedicated to Rousseau: *Eduquer selon la nature* (Desjonquères, 2012), *Rousseau et la théorie de l'homme* (Garnier, 2013), and *Les Confessions, se dire tout dire* (Garnier, 2015).

**Ryan Hanley** is professor of political science at Boston College. Prior to joining the faculty there, he was the Mellon distinguished professor of political science at Marquette University, and held visiting appointments or fellowships at Yale, Harvard, and the University of Chicago. A specialist on the political philosophy of the Enlightenment period, he is the author of *Adam Smith and the Character of Virtue* (Cambridge University Press, 2009), *Love's Enlightenment: Rethinking Charity in Modernity* (Cambridge University Press, 2017), and *Our Great Purpose: Adam Smith on Living a Better Life* (Princeton University Press, 2019). His most recent books are *The Political Philosophy of Fénelon*, and a companion translation volume, *Fénelon: Moral and Political Writings*, both published by Oxford University Press in 2020.

**Henry Higuera** taught at St. John's College, Annapolis (1982–2018). He is an expert on *Don Quixote*, on which he has widely written and lectured, including his book *Eros and Empire: The Problem of Christian Politics in Don Quixote* (Rowman & Littlefield, 1995). He has also lectured on Plato, Descartes, the foundations of modern science, and Hegel, and he authored "Gutierrez vs. the Vatican" (*This World*, 1989). From 1990 to 1997 he was a member of the National Council for the Humanities, and he was chair of its Public Programs Committee in 1993–1995. His BA is from Cornell University (1974) and his MA (1976) and PhD (1983) are from the University of Toronto.

**Pierre Manent** is professor emeritus at the École des hautes études en sciences sociales in Paris. After classical studies at the Lycée Fermat in Toulouse and at the École normale supérieure in Paris, and a period as Raymond Aron's assistant at the Collège de France, he taught the history of political philosophy at EHESS. His field of research covers the history of liberalism, the dynamics of political forms in the West, the question of the nation in its relationship to Europe, and finally the interaction between the

political order and the Christian proposal in European development. He has published many books and articles on these subjects.

**Jean-François Perrin** is professor emeritus of French literature at the University of Grenoble-Alpes. His most recent publications include a critical edition of the “Condillac” manuscript of Rousseau’s *Dialogues* and three essays: “Politique du renonçant,” “J.-J. Rousseau: *La Nouvelle Héloïse*,” and “Le chemin de ronde” (Paris, 2014). He is also the author of *Poétique romanesque de la mémoire avant Proust, XVII<sup>e</sup>–XIX<sup>e</sup> siècles* (Classiques Garnier, 2017–18) and *L’orientale allégorie: Le conte oriental au XVIII<sup>e</sup> siècle en France, 1704–1774* (Honoré Champion, 2015).

**Susan Meld Shell** is professor of political science at Boston College. Her most recent book is *The Politics of Beauty: A Study of Kant’s Critique of Taste* (Cambridge University Press, 2022). Her earlier books include *Kant and the Limits of Autonomy* (Harvard University Press, 2009) and *The Embodiment of Reason* (University of Chicago Press, 1996). She is also the editor of *The Strauss-Krüger Correspondence: Returning to Plato through Kant* (Routledge-Macmillan, 2012) and articles on Rousseau, Hobbes, and others.

**Nicholas C. Starr** is a tutor at St. John’s College in Santa Fe, New Mexico, where he has taught since 2016. He earned his PhD in political science from Boston College, and has held fellowships at the University of Virginia and Emory University.

**John Uhr** is professor emeritus of politics at the Australian National University, Canberra, Australia. He graduated with a PhD from the University of Toronto in 1979. Among his books are (with Shaun Crowe) *Novel Politics: Studies in Australian Political Fiction* (Melbourne University Press, 2020); *Performing Political Theory* (Palgrave Macmillan, 2018); (with Adam Masters) *Leadership Performance and Rhetoric* (Palgrave Macmillan, 2017); *Prudential Public Leadership* (Palgrave Macmillan, 2015); *Terms of Trust* (University of New South Wales Press, 2005); and *Deliberative Democracy in Australia* (Cambridge University Press, 1998).

## GUIDELINES FOR SUBMISSIONS

*Interpretation* welcomes manuscripts in political philosophy broadly conceived. Submitted articles can be interpretations of treatises of political philosophy as well as literary works, theological works, and writings on jurisprudence that have an important bearing on political philosophy.

All submissions must be in Microsoft Word® and sent, as an email attachment, to [interpretation@baylor.edu](mailto:interpretation@baylor.edu).

Submissions must be under 8,000 words, including notes and bibliographic references, and must be accompanied by an abstract of no more than 150 words. Because *Interpretation* is a double-blind peer-reviewed journal, all author identification and all references that would identify an author's own publications must be removed from the document. A separate title page, with the author's affiliation and contact information (including address, postal code, email address, and phone number) must be included with your MS.

Contributors should follow *The Chicago Manual of Style* (16th edition). *The Chicago Manual of Style* offers publications the choice between sentence-style capitalization in titles of books or articles and headline-style. *Interpretation* uses the headline style. Parenthetical references no longer use "p." or "pp." *Interpretation* has reverted to the traditional form of citation and no longer uses the author/date form. Please double space the entire text. Footnotes, rather than endnotes, are preferred.

Words from languages not rooted in Latin should be transliterated to English. Foreign expressions that have not become part of English should be accompanied by translation into English.

The editors of *Interpretation* are committed to a timely appraisal of all manuscripts, and expect to be able to have a decision on submissions within four to six weeks.
